
During 2017/18 ...

Tovertafel

We obtained two grants to purchase Tovertafel (Magic Table). Developed for people in the moderate to severe stages of dementia, it also provides distraction and stimulation to patients without dementia. The interactive games stimulate physical and cognitive activity and encourage social interaction. It is portable and can be mounted in different service areas, including the Inpatient Unit, Day Hospice/Day Care, Children's Counselling Room and the Education Suite.





Bistro/Café

Following extensive kitchen refurbishment works, a new Bistro/Café was opened at the beginning of March 2018 with extended opening hours from 8 am to 6 pm, seven days a week. The menu was expanded to include a varied selection of home cooked meals, breakfast options, paninis, jacket potatoes, salads and cakes alongside healthy smoothies, milkshakes and 'bean to cup' speciality coffees. The Bistro/Café is open to the public and has proved extremely popular.

Gardens

A grant was awarded to improve the grounds for patients and visitors. A new 'guard of honour' style walkway has improved pedestrian access and a new brick boundary wall and fencing has added privacy in the Inpatient gardens. The under-used front garden has been landscaped to include a walkway, bandstand, water feature and scented beds. Much needed additional patient and visitor car parking has been completed adjacent to the Holistic Wellbeing Centre.



New Bedrooms

The Hospice received private funding for the conversion of two additional bedrooms which allowed the Hospice to increase its bed capacity from 16 to 18 beds (8 specialist symptom management, 9 long term nursing and 1 respite). A wider variety of inpatient services allows the Hospice to have an extended referral criteria and support more patients in the local communities of Hartlepool & East Durham.

Our Care Activity

During the financial year 2017/18 Alice House Hospice made a vital difference to local people by providing the following care services:

167 referrals to our Inpatient Unit, providing 2,070 bed days to patients for symptom control and end of life care;

25 referrals to our Long Term Care Unit, providing 2,084 bed days to patients with Continuing Healthcare needs;

28 admissions for our Respite Care, providing 274 bed days in our Inpatient Unit and offering a chance for carers and patients to take a break;

699 attendances booked for our Day Hospice, where people living in the community with a life limiting illness can access specialist medical care, maximise wellbeing and get their symptoms under control;

1,460 attendances booked for our Day Care, where people living in the community can access support with their social care needs in a relaxed, friendly environment in our purpose built Holistic Wellbeing Centre;

7,321 individual Homecare visits bringing Hospice quality care to people in their own homes;

Assisting adults, young people and children coping with the loss of a loved one through our Community Bereavement Service. Support included 208 referrals with 1,037 individual counselling sessions and 29 support group meetings.

Answering 109 calls to the Hospice Helpline, which is designed to support people affected by a life limiting illness as well as health professionals;

502 Complementary Therapy sessions, aimed at maximising the wellbeing of the people who use our services.
