# 5.0 <u>REPORT FROM CHIEF EXECUTIVE OPERATIONAL AND CHIEF EXECUTIVE NON-</u> OPERATIONAL

### 5.1 Challenges 2022/2023

The Chief Executive Non-Operational reported on the following challenges during 2022/23:

#### **Change in Leadership**

- Former Chief Executive left 07 September 2023.
- Appointment of Co-Chief Executives to give stability and continuity to the Hospice at time of significant financial challenges.
- Costs savings as both Co-Chief Executives had retained their original substantive duties as well as absorbing the CEO role.

#### **Fundraising**

- Continued impact of COVID-19.
- Cost of living crisis, increased operating costs.

#### Shops

- Reduction in donated goods.
- Increased rental/utility costs.
- Lack of Volunteers.

### Lottery

Declining membership.

### **Grants/Trusts**

Competition.

### **Long Term Care Unit**

- Unsustainable operating costs.
- Restrictions of Continuing Healthcare funding only covering 50% of costs.
- Started consultations with staff and service users to close in March 2023.

#### **Community Bereavement Service**

- Heavily utilised with no funding closed December 2022.
- Re-opened May 2023 with grant funding from the Masonic Charitable Foundation managed by Hospice UK.

#### **VR Studio**

- End of Kickstart Scheme.
- Cost of living crisis affecting disposable income.

### CQC

- Last inspection March 2015.
- New single assessment framework being introduced.

#### 5.2 Achievements 2022/2023

The Chief Executive Non-Operational reported on the following achievements during 2022/23:

- £226,000 funding for 2 Emergency End of Life Beds.
- £100,000 funding NHS Staff Wellbeing Services.
- £70,000 over 2 years from the Musgrave Family Trust for Children's Bereavement Service.
- £286,756 additional funding for Stockton patients during the temporary closure and subsequent restrictions on Butterwick Hospice.

### 5.3 Strategic & Collaborative Working

The Chief Executive Operational reported on the following strategic and collaborative working during 2022/23:

## **Petitioning Parliament with Jill Mortimer MP**

- Tees Valley Hospice Chief Executives visited Parliament in January 2023 which resulted in further meetings regarding the funding challenges faced by the Hospice with Sam Allen (Chief Executive, North East & North Cumbria Integrated Care Board) and Helen Whately (Minister of State in the Department of Health & Social Care).
- Helping hospices to remain high on the Government's agenda.

## North East & North Cumbria Integrated Care Board (including Task & Finish Groups)

- NHS Tees Valley Place ICB's 'Adult Palliative & End of Life Care Strategy' historic disparity in the way that service providers are funded, reflective of the historic footprints of Clinical Commissioning Groups.
- Member of Task & Finish Groups which had been established to make recommendations to the ICB's Executive Committee on Service Specification, Contracting & Finance, Education & Training, Information & Communication).

### **Hospices North East & North Cumbria Collaborative (including Working Groups)**

- 12 independent hospices.
- Joined up working and sharing best practice.

# **North Tees & Hartlepool Education Alliance**

• Training in care homes to reduce A&E admissions.

## **Hartlepool Economic & Business Forum**

Linking in with local businesses.

### 5.4 **Plans for 2023/24**

The Chief Executive Operational reported on the following plans for 2022/23:

- Continued funding for 2 Emergency End of Life Beds.
- Continued funding for NHS Staff Wellbeing Services.
- Continued funding for Stockton patients whilst Butterwick remained under CQC restrictions.
- Funding/grants for Children's Bereavement Service.
- Funding/grants for Community Bereavement Service.
- Closure of Long Term Care Unit and future uses.
- Identifying grant funding for Hospice at Home model and Virtual Wards.
- Pay award review.
